

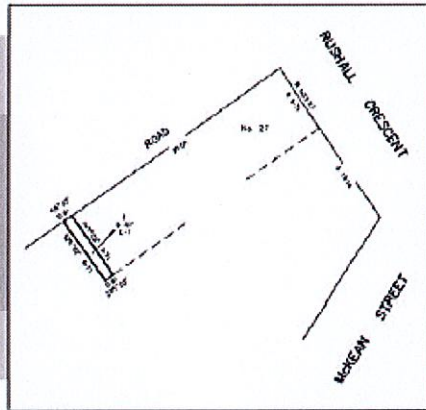

### PUBLIC NOTICE INVITING SUBMISSIONS UNDER SECTION 223

Yarra City Council (Council), acting under clause 3 of schedule 10 to the *Local Government Act 1989 (Act)*, proposes to discontinue the road abutting 27 Rushall Crescent, Fitzroy North, shown as Lot 1 on title plan TP954321U, being part of

the land contained in certificate of title volume 2378 folio 507 (Road). The proposal is that Council discontinue the Road and transfer Lot 1 to the adjoining owner of 27 Rushall Crescent, Fitzroy North.



Any person may make a submission on the proposal.

Any person wishing to make a submission under section 223 of the Act must do so in writing by **7 March 2018**.

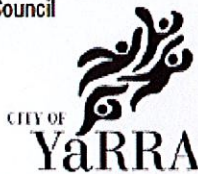
Any person requesting to be heard in support of his or her submission is entitled to be heard before Council (or its committee established by Council for this

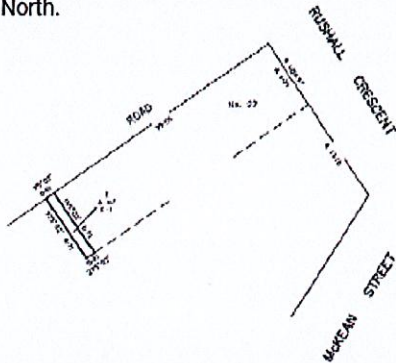
