The fence between the properties at 49 and 51 Dover Street does not have a gate in it and so 51 Dover Street has not been able to use this footway for access for sometime. There is also a shed sitting on this footway along the common boundary between 49 and 51 Dover Street. The abutting properties at 2 Fitzgibbon Street and 53 Dover Street do not have any entrances constructed along this walkway and do not seem to have ever used the footway for access.
