- 4. Council's work in relation to climate emergency short presentation by Sam Green, Climate Emergency Coordinator
  - Climate Emergency Plan can he found <u>here</u>
  - See slides attached with the Minutes
    - Noted the work of Rethink Recycling with the Collingwood estate in sorting bottle lids that then come back as cool products like skateboards.
  - Art space is somewhere people to come to when they are feeling despondent about climate
  - *Issue for future discussion?:* climate despondency, physiology, despair etc... What role could Council play in supporting out community around this?
    - Ideas more good news stories that don't have the emphasis on the individual having to take action. There is a feeling that individual actions are having less impact and that big business and legislation needs to change. Yarra should be more prominent in promoting and communicating the good news (in a way that isn't too vague)
    - Can we work with a Behavioural Scientist to help on messaging?
    - Climate justice and equity is very important
    - Potential to promote Climate 'Safe Spaces' where people can drop in a talk to others
  - *Issue for future discussion?* What metrics could/should we collect data on that could underpin the climate emergency plan?
  - *Q. Engaging with Young people will this include children?* Yes, but following good advice. Feedback that group that engaging Children is super important
  - *Q. If we say we are going where the energy is and where the leaders are to support them, what about the laggers. Have we targeted and how are we working with them.*
  - Q. Are we going to look at restorative in the next CEP?

• Fitzroy and Collingwood Planning Controls. Feedback Closes 3 Oct

A Design and Development Overlay (DDO) is a planning tool that is applied to areas such as activity centres like precincts and shopping strips that need specific requirements to guide the built form and design of new development.

In Yarra, DDOs generally try to achieve a balance between allowing new development and it needing to be sensitive towards heritage buildings, existing houses and backyards and avoiding overshadowing of public spaces like footpaths and parks.
