DELEGATES REPORT

Friends of Baucau Inc. is a not-for-profit community organisation that was formed to foster a partnership between the people and municipalities of Yarra, Darebin and Baucau District in Timor Leste.

In 2014, the Victoria State Government brokered municipal agreements between some Victorian municipalities and districts in Timor Leste to support the transition to a system of local government. A Municipal Agreement was signed between Yarra and Darebin Councils and the District of Baucau.

Friends of Baucau meets monthly in the Edinburgh Gardens Community Room to plan work with our partners in Baucau to provide financial and other support for a range of different development projects. Currently the main focus has been to support women's empowerment projects, teacher training, and sustainable livelihoods.

The Women's Economic Empowerment Committee also meets regularly to plan support for the 3 key partners focused upon supporting women in Baucau: the Centre for Women's Development (CFHD); Fundasaun Uma Pas, a women's shelter; and the Women's Association for Development in Baucau (AFEHABAD).

Following a challenging period for fundraising and communication during COVID, activities are now back in full swing with the Annual General meeting held in April alongside a fundraising event featuring the film "Circle of Silence" the story of Shirley Shackleton's quest for the truth about the Balibo Five.

The film makers, Collingwood locals Luigi Acquisto and Stella Zammataro, spoke about the making of the film and the efforts by Shirley who died in January this year before the film's release.

A second fundraiser was also held last week as part of Leaps and Bounds Music Festival. Spirit of Timor held at Collingwood Town Hall, featured Dili Allstars and Timor OANS and attracted a wide audience including many of East Timorese background.

Funds raised from these events and from the ongoing sales of coffee will support women's empowerment programs and a permaculture program in the District of Baucau.

Yarra and Darebin's Municipal Agreement has been on hold since the COVID lockdowns. However a delegation of local officials is expected in Melbourne later this year with Yarra hosting some. In return, a delegation of Friends of Baucau members and Neighbourhood House members from Yarra and Darebin will visit Baucau during 2024. This will provide an opportunity for both councils to reignite the municipal cooperation and for each council to investigate ways to support the transition to a form of local government in one of our nearest and poorest

neighbours.



Friends of Baucau Inc (FoB) is an incorporated community organisation based in the cities of Darebin and Yarra in Victoria, Australia. We promote friendship links between people in these cities and the communities of the Baucau Municipality in Timor-Leste.

We aim to:

- assist the people of Baucau Sub-District, through transfer of knowledge, skills, and resources as appropriate, particularly regarding health, education and training and community development.
- support projects aimed at strengthening communities and education selfsufficiency, and consistent with cultural, environmental and social sustainability in the Baucau Sub-District.
- build better knowledge and understanding between the communities of Baucau, Darebin and Yarra.
- work to achieve the above aims in conjunction with the City of Darebin and the City of Yarra.

We thank Darebin and Yarra councils for their ongoing support.

CONVENOR'S REPORT

In 2022 our small but dedicated committee continued our work with the 11 sucos in the sub-district of Baucau, Timor Leste.

We work closely with our partners in Baucau: Rui Sequeira, xefe of Samalare; Uma Paz, a women's safe house; CFHD Centro Feto Haburas Dezenvolvemento, a women's growth and development centre; and AFEHABAD, the women's association for empowerment in Baucau.

Our teacher training scholarship program, the *Salustiano Freitas Scholarship Fund*, provides fees and living allowance for trainee teachers from the Baucau municipality at the Instituto Catolico Para Formacao de Professores.

This year we were pleased to welcome a new member of the Committee of Management, Wendy Dinning, Acting Manager, Equity and Wellbeing, City of Darebin.

Our fundraising efforts this year included coffee sales, catering for Music In Exile at Fairfield Amphitheatre, and a House Music concert.

Many thanks to our supporters over the year, and especially to our dedicated committee members.

PROJECTS IN BAUCAU

Mana Femy Belo and the team at FUP serve the most vulnerable women through refuge, housing and legal advice. FUP reaches out to remote areas of Baucau. This car was partly supported by Friends of Baucau and makes trips on the challenging back roads of Timor-Leste a little easier.





Maun Rui Sequeira is a great advocate for his community's school. The community started a kindergarten but lack more than basic resources.

Mana Regina de Sousa and AFHEBAD team work closely with local women and community groups to create small businesses. This group sews clothes for sale at local markets.





FoB's Salustiano Freitas Scholarship Fund supports quality education in Timor-Leste, providing scholarships to young Timorese to undertake their Bachelor of Teaching at ICFP.

The scholarship applicants are selected on merit by ICFP, and then scholarships are awarded to students who pass the entrance exams but would have difficulty paying the fees.

Julieta is a recent graduate who was supported by FoB. The Bachelor of Education qualifies graduates to teach from year one primary school up to year ten junior secondary school.

FUNDRAISING ACTIVITIES

COFFEE SALES

Sales of Timor grown organic and fair trade sourced coffee continue to underpin our fundraising efforts each year. Coffee Mio in Thornbury source, roast, and package the coffee on our behalf. Our coffee sales took a hit during the pandemic but we managed to sell almost 200 kilos from late 2021 to August 2022. We have some arrangements with local neighbourhood houses, small retail outlets and cafes to sell the coffee. We welcome further inquiries regarding coffee sales and purchase. Coffee is available as ground or beans in 500 gram packs. A discount is given for sales of 5 kilos or more.

MUSIC IN EXILE

A wonderful summer music event held at Fairfield Amphitheatre, sponsored by City of Yarra. Friends of Baucau were invited to provide food for one Sunday afternoon. Thanks to Sabine and her husband Ade, we offered some tasty and very popular Timorese sweet and savoury snacks. Leanne Coughlin employed her catering skills, learned from community events at Alphington Community Centre, to whip up some very healthy salads, so that we could offer patrons a small meal. As it was quite a hot day, the Zuper Dupers, cold drinks and slices of watermelon were also a hit. Thanks to our very efficient team, Glenda Lasslett, James Pilbrow, Leanne Coughlin and Ursula Harrison.

CONCERT IN THE HOME

In December 2022 we held our second Concert in the Home. What a fabulous afternoon it was.

The very talented singer, songwriter and musician Gabriel Vargas entertained a group of 50 friends and supporters with songs from his homeland Brazil, his own compositions, and impressive repertoire of popular songs. And any titles the audience threw at him he could play and sing back to us!

It was an unseasonably hot afternoon early in summer, but everyone was thrilled to be there at what turned out to be our first live fundraising event since before the pandemic.

Proceeds from the event have been directed towards our teachers' training scholarship program, *The Salustiano Freitas Scholarship Fund*, and with a very generous offer from a supporter at the concert, a donation of an additional scholarship was made in memory of Jesse Chaplin-Burch. Sincere thanks to Gabriel Vargas for donating his time with passion and enthusiasm, and to Kathleen Walsh and Graham Lanphier for hosting the event once again.



TREASURER'S REPORT

Following a challenging three years for Friends of Baucau a return to relatively normal operations has led to financial improvement in 2022. Coffee sales provided a strong ongoing revenue stream. In February catering for a City of Yarra Music In Exile concert boosted our finances as did the December House Concert.

Also worth noting, the absence of expenses usually incurred for travel between Australia and Timor-Leste. There was no travel expenditure in 2022 and 2021, compared with \$4,900 in 2020 and \$14,700 in 2019 (Neighbourhood Houses visit, offset by participant contributions)

A comparison of revenue and costs between the 2022 and 2021 financial results reveals:

Revenue

- A decrease of \$5,300 in Council support grants. A total of \$800 was received from City of Yarra for the Music in Exile concert catering.
- An increase of \$3,223 in coffee packet
 sales
- The House Concert in December realised \$3,279 from event ticket sales, wine and coffee sales, raffle proceeds and donations.
- A decrease of \$4,420 in donations.

Expenses

- Insurance policy renewals were \$679 lower, as 2021 and 2020 renewals were paid in 2021.
- Coffee packet purchases and associated costs were \$3,326 lower.
- Music In Exile Festival catering stall costs of \$891 were incurred.
- FoB incurred expenses for catering and performance costs for the METAC Cultural Dinner at Belgium Avenue Neighbourhood House.
- Expenses of \$1,983 were incurred for the House Concert
- Website hosting/subscription renewals were \$732 higher because we paid 2021 and 2022 together.
- City of Darebin Food Act annual registration fee (required for the operation of event catering activities) of \$495.
- Timor-Leste programs/special appeals funding was \$20,239 lower in 2022. Funding comprised the Salustiano Freitas Scholarship Fund contribution (\$690) and a grant for the purchase of new furniture for the Baucau community centre (\$1,100).

NB: In kind support from The City of Yarra for meetings venue hire - refundable bond (\$100), swipe card replacement (\$44)

Financial Year Result

The above items resulted in a surplus of revenue over expenditure of \$3,127 in 2022, compared with an expenditure excess of \$12,944 in 2021 (there was an excess of expenditure over revenue of \$5,983 in 2020).

The end-of-year cash balance in 2022 was \$46,580, compared with a balance of \$43,453 in 2021. In November 2021, FoB opened a second Bendigo Bank account with a debit card attached, to enable more efficient payment of smaller expenses. A balance of \$500 was included in the 2022 amount above.

DELEGATES REPORT

The Collingwood Children's Farm was founded in 1979 to support and engage children experiencing adversity.

The Farm supports social inclusion through a range of community programs delivered on a working farm. These programs develop self-esteem and connectedness particularly for children and those experiencing adversity. The Farm facilitates the participation of children and their families in broader community life and encourages a connection to nature. Its school, work experience and volunteer programs provide educational opportunities around urban agriculture and can offer pathways to further employment in the industry. Visitor feedback is consistently positive.

The Farm is located on Crown Land and is managed by a volunteer Committee of Management elected by Farm Members each year. This committee meets monthly with subcommittees which also meet regularly and an annual strategic planning day. The current committee is a strong skills-based committee.

A Councillor delegate has been appointed to the committee since its inception, under the committee's Constitution. The Farm receives grants from Yarra Council from time to time, including for the long running Young Farmers program. The Farm also partners with Yarra Council on a range of projects including composting, urban agriculture and the work of the Narrap Rangers.

The Farm suffered significant financial losses during the COVID lockdowns, like many not-for-profit organisations, and is still recovering. It derives its income from admission fees, memberships, sales of produce and a small number of paid programs which subsidise the other unpaid programs for the target cohort.

A new Farm CEO, Bert Ferro was appointed late in 2022. Bert is an accountant with a strong history in not- for-profit organisations and is well-placed to steer the Farm through its next phase.

The key focus for the Committee of Management for the next 12 months includes:

- Post-COVID recovery and establishing the Farm on a sound financial footing
- Increasing programs which cater for those community sectors experiencing disadvantage
- Re-establishing the community gardens
- Proceeding with new community rooms, funded by the state government.

The Committee of Management is also focused on reviewing and enhancing its governance structure, ensuring appropriate skills are attracted to the committee, and ensuring financial stability for the Farm.
