6. Question time

This section is provided as a record of the questions submitted and asked during question time and the responses prepared - it is not a transcript of proceedings. A recording of the Council meeting is available on Council's website for at least twelve months following the meeting.

The following questions were asked:

1. Peter Jamieson:

Question:

Could I please have an update on the petition submitted at the last council meeting, requesting consideration of additional free parking for customers of traders in Brunswick St (northern end). I also understand there is currently underway a review of parking arrangements in the City of Yarra. What is the purpose and scope of this review and when will it be completed?

The General Manager City Sustainability and Strategy provided the following response:

The submission of the petition is noted and is currently being considered and a response will be provided to you by end of week. As previously outlined to you, paid parking along all of Council's activity centres assists in preventing long -term occupancy of spaces and encourages turnover making parking more accessible to the community and promotes other forms of transport.

In response to the query regarding the Kerbside and Parking Strategy, the study will include consideration of parking fees and impacts and demands for on-street car parking in Yarra and will consider the future growth anticipated for the municipality.

2. Janet Adams:

Question:

Can council provide clarification of its risk management requirements for residents who require laneway access to maintain their property?

The General Manager Infrastructure and Environment provided the following response:

As we have indicated in our correspondence to you recently, all occupation of Council assets requires permission to ensure public safety around work sites. Our approach prioritises the safety of workers and contractors, pedestrians, motorists and cyclists while also ensuring the protection of Council's assets from damage. We do this through the requirement of a traffic management plan and we try to offer sensible and affordable solutions to keep costs down (including reduced costs for residential works).

3. Peter Razos:

Question:

In the last five years in the City of Yarra, how many car spaces have been removed because of bicycle lanes in the City of Yarra?

The General Manager City Sustainability and Strategy provided the following response:

A number of teams across council deliver bicycle projects including the state government. In many cases parking spaces affected by bicycle lane installation are moved or replaced nearby rather than removed entirely. To undertake a review over the past 5 years would be a manual task that has not been undertaken but as an estimate, there are approximately 45,000 car parking spaces in Yarra and we believe less than 1% of these would have been affected by the creation of safe bicycle lanes.

4. Nancy Molloy:

Question:

What are Leisure Services intentions regarding the Empower Programs?

The General Manager Infrastructure and Environment provided the following response:

Thanks Nancy for your question. I note we are meeting this week to discuss your various queries so perhaps we can add the empower programs to the list.

There are no plans to change the Empower Programs from its current format or structure. The program is made up of two class types:

- The Empower Classes support people with chronic conditions who require minimal support.
- 2. The Empower + classes which are strength training sessions for people with disabilities who require a high level of support. This program is perfect for people who can use gym equipment with the support of their own carer.

We are running at 35% occupancy levels at present so there's plenty of room for more participants. See you on Thursday.

How are you measuring the use of the temporary Charlotte Street pop up park?

Question:

How are you measuring the truest impact of traffic on the surrounding streets due to the closure of Charlotte Street?

7. Hugh Morley:

Question:

With regard to the Charlotte Street pop-up park outside the Richmond Library - what is being done to remedy and ensure public safety issues that have arisen since its inception?

The General Manager City Sustainability and Strategy provided the following response to questions 5 to 7:

Thank you all for your questions

A one-week traffic study is recommended by traffic engineers and typically standard practice for projects of this scale. The study will be undertaken by an independent traffic specialist engaged by Council. The date selected for the study has been chosen to avoid school holidays and to occur with sufficient time after the implementation of the temporary pop-up park to allow for traffic patterns to settle meaning drivers being aware of the altered conditions. Also, during the time of the study there are multiple AFL games at the MCG which the community noted were important to consider during the study. Once we have collected this data, we will be reviewing this along with VicRoads data, and information gained from the previous study.

In response to the use and amenity impacts from the pop-up, Council understands that there are a number of issues in the area many of these preceding the temporary pop-up park, however any concerns can be reported to Council, and we will work with the community to address them.

We have received feedback about the pop-up including how people are using the space but we are not undertaking formal counts of people using the space as the pop up does not reflect the final design and is in place to inform Council of impacts of a permanent park in this location. Any permanent park will have additional lighting, improved pedestrian accessibility, open sight lines all to ensure that the space is as safe as possible for future users and those walking through or accessing the library.

8. Victoria Chipperfield:

Question:

Last month I asked if the refurbished toilet block in Citizens Park met the Australian Standards outlined by Sports and Recreation Victoria. The response from Council was that as it is not attached to the pavilion that was not required. The issues raised last time were due to concerns for people experiencing a health episode and ambulance officers not being able to provide timely responses as the doors opened inwards. Now that these serious concerns have been raised, will Council change the doors to open outwards?

The General Manager Infrastructure and Environment provided the following response:

The public toilets at Citizens Park are compliant with building regulations. The doors to the cubicles have lift-off hinges to enable access to the cubicle in an emergency, as is required by the National Construction Code. The doors for the accessible and ambulant toilets at this location open outwards, whereas the doors for the remaining five standard cubicles open inwards, due to the constraints of the site. We have no plans to change the doors at this time.

9. Sharon Harrison:

Question:

In December 2023, the Local Government Minister stated that it is good practice for a council to align a Waste Charge with the specific service provided to the occupancy it is levied upon and should not include other costs. Examples of costs that the Minister considers should not be included in a Waste Charge include: Litter and waste collection from public spaces and the provision of public bins Street, footpath and drain cleaning Graffiti removal Tree planting and maintenance Park maintenance, public education and advocacy Local Government Finance Professionals (FinPro) is the peak body servicing Local

Government Finance Professionals in Victoria. In January 2024, they publish a survey that nearly 80% of Councils incorrectly include at least one of these costs. Question: What information will Council provide to the community that will clearly, simply and publicly demonstrate that Council will not include these charges in Yarra's Bin Tax?

The Manager People and Culture provided the following response:

Local Government Victoria released the Guidelines in late December. The guidelines are not legally binding and together with the local government sector we are working to better understand the intent of guidelines and what, if any actions are required.

It is also important to note that during the process of separating waste service charges from general rates last year, Council worked closely with the Essential Services Commission to ensure compliance under the law. Our compliance was reflected in the Commission's Rate Cap Compliance Report for 2023/2024.

10.1 Councillor Landes - Local Area Place Making Plan

Question:

It was noted that the LAPM for the Vaucluse area in Richmond which was referenced in the Council Plan that an internal road safety review was undertaken for the Vaucluse as a corridor study for Richmond. This identified that the Vaucluse would benefit from a painted shared zone, design approvals and delivery of a shared zone would be progressed during the 2023/24.

Can officers advise residents when this would be proceeding?

The General Manager Infrastructure and Environment provided the following response:

Officers have developed a shared zone concept for the Vaucluse, essentially the Church Street end up to the community services building. The current proposal is based on a proposed lower speed limit of 20k per hour. Signage and some pavement marking with some public messaging to be proposed which we found effective elsewhere. We have discussed this already with DTP and are going through the process of submitting it to DTP for its consideration and are confident that it fits the shared use template and would be successful but of course we just have to wait for DTP's approval. Should it be successful we are confident that we would be able to deliver it next year.

10.2 Councillor Stone - Planning Processes

Question:

In relation the October 2023 report outlining the changes to the planning processes in Victoria following the Premiers housing statement. Many of those changes were premised on Council's being slow to process applications and also the perception that delays were being caused by third party objectors and so these reforms removed third party rights from several types of applications and removed Council's as decision makers on several types of applications. At the time it was advised that it was difficult to know what the impact would be on Yarra in terms of our processes because of the lack of detail. Has any other detail been provided since then and if so, what?

Yarra has made some strong statements about the fact that better planning outcomes are achieved when communities are involved in those decisions. The Council resolution in October referred to the advocacy by Council on the this and I was wondering can you describe what advocacy has been undertaken and how it's been responded to since then?

The General Manager City Sustainability and Strategy provided the following response:

We understand the department are preparing some guidelines for community, Councils and applicants to understand how the process will run. We haven't seen drafts of those yet but we have requested and have said that are more than happy to review those in light of the number of guidelines that we prepare on our website for our community to understand the planning process.

Council officers, I will start at that level, every time we are contacted by the department with respect to, I'll call it a call in application just for clarity, we advocate strongly regarding this scope of engagement with the community and in many instances we ask for that scope to be significantly increased as we are providing names and addresses for those properties. We have been quite successful in being able to influence the outcome at officer level. Further to that we have met with the Minister, the Mayor and CEO and again we advocated strongly for community input into these processes and we continue to have those discussions at all levels within the department and obviously we have had conversations directly with the Minister and we will continue to do so on a case by case basis as the applications are called in.

The CEO also provided the following response:

The matter is being raised regularly with the Mayor and our local MP's and indirectly I know that on occasion MP's have taken the opportunity to ask questions, specifically most recently about our Open Space amendment. For example in Parliament and as well as making approaches to the minister specifically. In addition, the M9 group of Council's recently, it doesn't go directly to the consultation point but it does go the impact of the reforms, the M9 CEO's recently wrote to the department and asked for the department to consider and respond to issues relating to cost shifting. It is my view and the view of the other Councils that we will continue to do the lion's share of the work, but we no longer receive the applicant fee and in order to ensure that the community is well represented in decision making we need to commission external subject matter experts at rate payers expense, so I don't believe that is fare, so I've asked for that to be raised as well. There has been a lot of media attention and we have taken every opportunity to remind the readers or the listeners that Yarra has done the lions share and done the heavy lifting in terms of residential development approvals in the metropolitan area recently and so we actually feel we are doing a reasonably good job with our compromising and the involvement in the local community.

Councillor Nguyen left the meeting due to conflict of interest at 9.56pm.

10.3 Councillor Jolly - Electric Vehicle Charging Points

Question:

Can you please provide an update if you have one on the roll-out of the electrical vehicle charging points in the City of Yarra?

Also, any idea when we are going to receive a report about the potential roll-out or advise as to the successor otherwise of the trial at Port Phillip and UK cities that have embedded charging points that would suit private houses which I know are quite rare in the City of Yarra.

The General Manager City Sustainability and Strategy provided the following response:

Council isn't currently a recipient of a grant for the installation of EV's and we are working with the infrastructure team on implementing these. We are still working on them so please don't take that there is a stall, but they are not as easy to implement within our existing infrastructure. We are also working on a policy that is to guide where we should be putting EV's across the municipality and also advocating for the installation of EV's within private developments, which may not address all issues but at least with all new developments people will have the option of having an electric vehicle. All of this work forms part of or a part of the kerbside strategy and we will come to you with the timing for when these policies will be put to Council. There was also a question about power cords across footpaths. I have had a conversation with our local laws team and we are working towards, is there a solution about how these can be implemented. It is a complex topic so I will circulate further information for Councillors about each of those topics.
