Good afternoon Stephen,

As discussed, I have been advised that there is a standing permit exemption for all works, including demolition, to non-registered buildings and structures on land classified as L1 on the registration. Heritage Victoria considers the fence to be a structure within L1 and the removal is therefore covered by this standing exemption. Heritage Victoria will take no further action on this matter as we reasonably believe that no offence has been committed. However, the standing exemption does not allow additions to non-registered buildings and structures on L1. You will require a heritage permit or permit exemption should you wish to rebuild the fence. Good afternoon Stephen,

I received information that the boundary fence at the Christian Israelite Sanctuary, 193 Fitzroy Street Fitzroy has been removed. The Christian Israelite Sanctuary is a registered heritage place (VHR H0097) and is afforded protection under the Heritage Act (the Act). As we discussed, removal of the fence without a permit or permit exemption is an offence under the Act.

Please ensure that no further works take place on the fence until this matter is resolved and the appropriate approvals

in place. Under normal circumstances Heritage Victoria would conduct a site visit to collect required information, including an interview with relevant parties if necessary. Unfortunately this is not possible at present due to Covid restrictions. I will discuss this matter with our team early next week to work out the best way forward.
