8.1 Tourist Bike-Safe Cultural Trail

 - (i) include a budget bid for consideration in Council's 2018/2019 Council Budget;
 - (ii) identify levels or phases of implementation from the most basic traffic treatments and way-finding measures to more complicated versions that may include coloured pavement, filtered permeability, upgraded crossings on main roads and an integrated marketing campaign;
 - (iii) consider a route that includes Vere Street, Perry Street and Greeves Street; and
 - (iv) other potential sources of funding and collaborators.

9. Delegates' reports

9.1 Councillor Stone - 23rd Conference of the Parties to the United Nations Framework Convention on Climate Change (COP23) Bonn, Germany - 6-16 November 2017

Councillor Stone reported the following:

The United Nations Framework Convention on Climate Change (UNFCCC) entered into force in 1994 and now has universal membership of nations. The nations which have ratified the Convention are known as Parties. Each year a Conference of the Parties meets to review the implementation of the Convention and any other legal instruments that the COP adopts, and takes decisions necessary to promote the effective implementation of the Convention, including institutional and administrative arrangements.

The 23rd Conference of the Parties (COP23) was held this year in Bonn Germany and for the first time local and regional leaders were invited to take part in the proceedings with a specific programme of dialogues, summits and presentations as well as a full day **Climate Summit for Local and Regional Leaders** on Sunday 12th November.

I attended this through our involvement with ICLEI and the Global Covenant of Mayors.



Whilst national leaders and negotiators were discussing greenhouse gas emission reduction targets and financing in the "Bula Zone", local and regional leaders and other delegates shared their goals, successes and ambitions in the "Bonn Zone".

A number of side events and local excursions were also organised by the state government of North Rhine-Westphalia.

Coming 2 years after the historic Paris Agreement at COP21, the focus on this COP23 was on implementation and financing of measures needed to keep global warming below a 1.5 degree increase.

There was also an emphasis on aligning actions with the Sustainable Development Goals and also the New Urban Agenda adopted at Quito in November 2016.

As part of the programme of dialogues, presentations and summits, I contributed to a seminar on "Low Carbon Transport: Moving People and Goods, Not Vehicles" with a presentation on **Ecomobility in Melbourne** (attached).

This session was sponsored by the Ecomobility Alliance, a group of local governments with a common goal: to create and implement urban mobility strategies that prioritize people and the environment, supported by ICLEI. Yarra was invited to

join the alliance and details about what this involves are attached.

With the transport sector accounting for over 23% of global greenhouse gas emissions – and rising – reducing transport based emissions is critical to the effort in limiting temperature rises as well as reducing air pollution in cities.

Whilst Yarra is doing well with its mode share and investment in sustainable transport measures, it was clear that metropolitan Melbourne is lagging behind the approaches taken in other cities worldwide, and presented at this forum, with its centralised economy, sprawling residential areas, continued expansion of freeway infrastructure, continued incentivising of car-based transport and minimal investment in or incentive for active transport.

Ecologistics was also a focus of this session with positive progress being made in many cities, such as

- Smart Freight Centre Netherlands, focusing on assisting freight companies to
 work more efficiently, using less fuel and in a more sustainable way, and by a
 developing a universal method of calculating freight emissions. With 40% of
 freight vehicles (trucks, planes and ships) carrying no load, there is great
 potential for emission reductions through knowledge, collaboration,
 technology and logistical assistance.
- Kaohsiung, Taiwan where "the last mile" for freight is increasingly being delivered by e-bikes and scooters, using less fuel for short trips, greater access in a congested urban environment and fewer parking and loading issues.



EcoLogistics:

Low carbon freight for sustainable cities

- Funded by the Federal Ministry for the Environment, Nature Conservation, Building and Nuclear Safety of Germany (BMUB) through its International Climate Initiative (IKI) program
- November 2017 October 2021
- Outcome: Cities have enhanced capacities, strategies and policies to promote low carbon urban freight through local action and national support



Climate Summit for Local and Regional Leaders 12th November

This full day summit heard from local, regional and national leaders who were unanimous in their messages, that:

- We face an urgent challenge in mitigating the impacts of climate change
- We are not yet on track to fulfil the Paris Agreement

- Climate action should support the Sustainable Development Goals
- There is no time to lose, we do not have decades
- For many nations this is a current and an existential issue
- The cost of not acting now far outweighs the costs of keeping global warming below 2 degrees
- Developing nations, especially in Africa, were among the strongest voices and want to be partners in the global effort
- Financing of actions in developing nations is a major obstacle
- All levels of government have a role to play and must lift their ambitions, but local governments are currently driving climate action and this is likely to continue to be the case

The Summit concluded with the 330 leaders committing to the Bonn-Fiji Commitment, http://www.cities-and-regions.org/cop23/wp-content/uploads/2017/11/bonn-fiji-commitment-of-local-and-regional-leaders.pdf

The commitment involves lifting targets to meet the Paris Agreement aligned with the Sustainable Development Goals, and working with other levels of government to achieve these goals.

Other outcomes included these ICLEI initiatives:

- Climate Reporting Partnership combining 2 climate reporting platforms, Carbon, the Climate Reporting Registry, and CDP, to build a robust database of self-reported climate commitments, actions and performance tracking
- Front-Line Cities and Islands a coalition of coastal cities and islands on the front

line of the impact of climate change, many in our immediate region including New Zealand and Fiji.

The summit demonstrated both the voice of local governments across the world in pressing for stronger climate action and financing, but also the enormous effort already being undertaken at a local level to build resilience of local communities in adapting to a changing climate and to take the actions needed to reduce our greenhouse gas emissions. ICLEI concluded that:

- COP23 proved that the Paris Agreement is unstoppable and irreversible –
 where local and regional governments are positioned to be a strong
 custodian.
- 2. National goals are not strong enough and the global emissions gap is huge This is the perfect time to engage local and regional governments in delivering national commitments and raise ambitions globally.
- 3. The Talanoa Dialogue opens the door wide open for multilevel and multistakeholder partnerships – Local and regional governments now have the opportunity and duty to extend this to every city and region in the world.
- 4. Advancing the Paris Agreement Work Program has enabled progress in building a strong global climate architecture.
- 5. The road ahead we have 3 critical years ahead of us to safeguard the Paris Agreement and the global climate.

In addition to the summit, I attended an excursion to the city of Essen, Europe's "green capital", and a former coal mining district, to learn:

- How a region dependent on coal mining has reinvented itself and is creating an alternative economy
- How other industries (such as an aluminium smelter) are adapting to a new energy future
- How local and state governments are partnering with not-for-profits, energy companies and universities to drive innovation in residential areas with social housing and support low carbon living.

There was much we could learn in Victoria from partnering to renew public and social housing with a clear goal of improving climate adaptation reducing energy consumption and carbon emissions and building community resilience.

COP23 was the first conference hosted by a small-island developing state (Fiji) whose very existence is under threat from sea level rises. It was also the first global climate meeting following the announcement by President Trump in June that the US intended to pull out of the Paris Agreement. However with the terms of the agreement preventing that occurring until after the next election and with the mobilisation of US local governments in the "We're Still In" movement, the conference proceeded with a focus on implementation of the Paris "Rule Book" and developing finance options for climate action in developing nations.

The greatest energy was clearly in the local government sphere where innovations and persistence were hallmarks of local governments globally.

In conclusion, whilst the outcomes of negotiations in the Bonn Zone were underwhelming for some, the collection of local and regional actions and aspirations at COP23 was significant and demonstrated where the action on meeting the Paris Agreement lies and will probably continue to lie. The emphasis on partnerships and collaboration could not be understated.

Given that Nationally Determined Contributions (NDCs - each nation's commitment to keep the global temperature rise below 2 degrees Celsius by the end of the century, and aiming for a lower, 1.5-degree increase) are inadequate and, at current projections, will result in a rise of 3.2 degrees above pre-industrial levels, a positive outcome of the conference is the acceptance of ICLEI as the first non-country associate member of the NDC Partnership. This move will provide opportunities for all levels of government to strengthen systems and coordination mechanisms that enable all levels of government to take joint action on climate change. Yarra is part of a global effort to stem the impacts of devastating climate change and we are lifting above our weight as an organisation.

However there is more that we can do to support our community to adapt to a changing climate and to reduce emissions so that the worst case scenario does not occur. We are in a position to lead in the local government sector in Victoria. The one thing this conference was unequivocal on was that there is very little time in which to act. As Gerry Brown stated "Anyone who gets it has an obligation to act."

Referring to the article; housing is increasingly being built assuming air-conditioning as the main coolant, ceilings heights were too low for safe use of overheads, while homes lacked eaves and space for vegetation etc.

I notice that this is also an issue for Yarra and would like this referenced in the planning scheme review, that we look at ceiling heights to enable ceiling fans to be installed rather than relying on air-conditioning and secondly, eaves and space for vegetation to provide shade and oriented to account for sunshine exposure.
