7.1 Ms Dorothy James - Budget Information Sessions

7.3 Mr Herschel Landes - Telecommunication Pits

Question:

Yarra Council is the statutory authority for the purposes of the public footpath spaceto manage and maintain and to ensure access to buildings, equitable pedestrian amenity and safe public transport interfaces, bicycle storage, seating, plantings etc. while balancing a wide range of permitted activity.

Of recent times there has been increased activity when it has come to the upgrade of telecommunication infrastructure.

I refer to general disruption and the management and maintenance of telecommunication access pits and lids. As I have previously noted, increased density of access pits has become a visual dogs breakfast in some places while the lack of maintenance is creating numerous trip hazards and areas of poor pedestrian accessibility.

In the examples I have tabled the matter has been before Council over an extended time period of many months.

Could Council please explain why is not able to provide a reasonable and timely response to ensure that telecommunication access pits are managed with minimum access disruption for relevant stakeholders and that lids are maintained in reasonable and safe condition?

Question:

I refer to a pictorial advertisement on page 5 of a recent Council publication - Yarra News.

This pictorial seeks to purport the distribution of \$100 of rate revenues under a heading - Where do your rates go?

The \$100 base in the pictorial advertisement actually refers to the Council's \$205 million total expenditure budget (including capital), rather than, Council's \$105 million rates revenue income. The \$100 million gap is made up of variable fees, fines, charges, grants, contributions should be have been explained in the advertisement.

I believe it was misleading not to have clearly identified the \$31million or so cost of indirect Council administration expenses such as CEO's office, finance, interest, public relations etc. being spread across all categories. I put it to Council that this would have represented one of the top expense categories for the illustration and which may not have been looked upon favourably, by rate payers- especially after the bin tax and three adverse Herald Sun editorials.

<u>Section 136 of the Local Government Act requires Council to ensure full, accurate</u> and timely disclosure of financial information relating to the Council.

My question goes to the validity of a budget submission process when Council publishes material that is misleading or seen to be misleading and will not provide readers with an informed view of Council income and expenditure in a draft budget that is the subject of feedback.

Response:

The Director City Works and Assets advised that the pits are not a Council asset. Council officers can investigate the site to ensure that the site is not a safety hazard and can write to the Telecommunication company to inform them of some of the issues.

The Mayor advised that the graphic was merely one piece of a vast array of information publicly available.

<u>Local Government budgets and performance are more transparent than any other level of government, government entity or indeed any other sector.</u>

We welcome scrutiny by the community and our performance is overseen by a vast array of external bodies from VAGO and the Essential Services Commission through to Local Government Victoria and the Victorian Ombudsman.

The illustration you have focused on this instance is just a snapshot. We actively encourage people to look at the detail.

7.4 Mr Zev Landes - Works on Bridge Road

8. General business

8.1 Councillor McEvoy - Bike Parking

Background

Yarra City Council is committed to encouraging sustainable transport.

Our most recent Bike Strategy states:

"In Yarra, a cycling culture has existed for many years with the number of residents regularly cycling being the highest of any Council area in Australia. Approximately half of all cycle trips in Yarra are from neighbouring areas who travel to Yarra for work, shopping, leisure and education purposes, or are travelling through Yarra to access the CBD and other neighbouring precincts including Melbourne University, Docklands, and St Kilda Road.

The City of Yarra Strategic Transport Statement 2012-2016 committed Yarra to providing the community with attractive alternatives to car use. A key component of this commitment is to deliver infrastructure projects and support behaviour change measures that encourage a broad cross section of the community to travel through, to, from and within Yarra by bicycle. Cycling volumes on Yarra's streets and of-road paths have continued to steadily rise over the last ten years, and a number of strategic demographic, socioeconomic and transport factors suggest this trend will continue for the foreseeable future.

Yarra has set ambitious targets for bicycle mode share increases over the coming years that will align it with those of other world-leading cycle cities such as Amsterdam and Copenhagen."

Bike share schemes should be supported as part of these goals.

However, the use of public space in Yarra is often highly contested, and Yarra City Council has policies to manage car parking, footpaths, parks and open space, especially where private enterprise seeks to utilise the space. For example, businesses are required to apply for permits for café tables and signage, and when personal trainers use public parks for fitness classes.

Each year the City of Yarra commits money to expand and maintain public bike parking throughout the municipality. It is recognised that as cycling rates increase, bike parking is a growing need. Cyclists are permitted to park their bikes on footpaths and at designated bike hoops. In some instances, however, abandoned bikes are removed by Council officers under local laws.

The recent arrival of O-Bike, a commercial bike share scheme, is cautiously welcomed by our community. A balanced response is required to manage the impacts on public space while encouraging cycling as an alternative mode of transport.

Background: Submission to West Gate Tunnel Environmental Effects Statement

Melbourne's geography demands a deep and thorough understanding of the interconnected relationships between all transport modes. Localised solutions, such as the West Gate Tunnel project, especially when focussed on one transport mode cannot be assessed in isolation from this broader perspective. Even the funding of these types of solutions is important, as they have long term impacts on other modes and transport options. Yarra Council asserts that a solution to traffic congestion such as this is the opposite of future proofing. It consumes limited connection points into the city, creating not just more induced traffic, but making future solutions longer or more complicated to achieve, as well as restricting the flexibility to introduce other mode solutions. The West Gate Tunnel Project has been proposed by a stakeholder which will benefit from its construction (Transurban) and not as part of a wider strategic approach to sustainable transport planning in Melbourne. The environmental effects are being considered as an afterthought and not built into its conception or rationale. For these are the following specific reasons, the Project should be rejected.

Whilst the West Gate Tunnel project is proposed for the west of Melbourne connecting transport routes between the port, Citylink and the city connections, the impacts will be experienced more broadly, especially in relation to traffic flows in Melbourne's inner north and in the City of Yarra.

The West Gate Tunnel will generate tens of thousands more vehicles commutes into inner Melbourne every day. Some of this traffic will be pushed through North Melbourne and Parkville and into the City of Yarra. This traffic will worsen local traffic conditions in the City of Yarra, particularly along arterials such as Victoria Parade and Alexandra Parade which are already at capacity.

Data in Chapter 25, Figure 25.6 shows an expected additional 2,000 vehicles per day along the eastern end of Victoria Parade, an additional 1,000 along Queensbury Street and an additional 900 along Grattan Street. All 3 streets have traffic originating in or through Yarra, either from key transport routes to/from the north and east or via the Eastern Freeway.

Whilst described in the EES as "minimal", these amounts add to increasing traffic burdens and act to undermine recent measures taken in Victoria Parade to provide dedicated bus and bicycle routes to prioritise and encourage these modes of travel.

The City of Yarra notes with concern the separate findings in the City of Melbourne report on the Project (Melbourne City Council Meeting Agenda Item 6.5, 4 July 2017) that:

- the Dynon Road connection will feed traffic into the local road network exacerbating congestion creating peak hour conditions for 12-14 hours every day along key inner Melbourne east-west streets;
- added congestion will negatively impact tram performance of 13 trams routes in Melbourne's inner north and west;
- the Project is inconsistent with developing land use in the E-Gate, Arden McCauley Road area and along the Maribyrnong River;
- it will negatively impact open space along the Maribyrnong River and Moonee Ponds Creek

Extensive experience in Melbourne, interstate and internationally has shown that such toll roads within cities do not improve traffic conditions. They induce traffic such that travel times return to

baseline soon after the toll road is opened. This is a concern, held by Yarra Council, that the "modest" increases in induced traffic along these three routes will not contribute to improved transport across inner Melbourne and, on the contrary, will continue to provide further pressure to construct more major road projects, such as the rejected East West Link, which are unsustainable and would have a detrimental impact on the residents of Yarra. It is assessed that any initial benefits will, through such induced traffic, likely be eroded within 3 years, and at best, within 5 years.

The only way to provide ongoing sustainable transport options, to reduce congestion and improve quality of life in the western suburbs of Melbourne is to invest in public transport, particularly rail services and feeder buses, to enhance conditions for walking and cycling, and to shift freight from trucks to rail. As the WestGate Tunnel project will be counter-productive in alleviating congestion, and will negatively impact on public transport, walking and cycling, it should not be approved.

There is further concern that the West Gate Tunnel Project is being pursued in the absence of proper transport planning in accordance with the requirements of the Transport Integration Act 2010. Section 63 of the Act requires the State to prepare a long and medium term transport plan having regard to mandated transport objectives and decision making principles. These include economic social and environmental parameters as well as objectives to reduce reliance on private motor vehicle transport and support sustainable means of transport. There is no such State transport plan which has been prepared let alone one which includes the West Gate Tunnel project. In the absence of this mandated planning requirement, it is submitted that it is inappropriate to proceed with a project such as the West Gate Tunnel.

The Act also requires that all government transport and planning bodies have regard to the Act's mandated transport system objectives and decision making principles. Given the projected induced transport demand from the West Gate Tunnel, and the anticipated exacerbation of city congestion arising, it cannot be said that a decision to proceed with the West Gate Tunnel project would have had appropriate regard to those transport system objectives and decision making principles which require sustainable means of transport.

It is therefore submitted that the Project is contrary to proper transport planning in accordance with the requirements of the Transport Integration Act and thus should not proceed.

- The bicycles are able to be tracked by the operating company as they are equipped with a GPS system
