7. Public question time

7.1 Mr Herschel Landes - Coles Plaza/ Carpark

Question:

The Bridge Road Streetscape plan that was recently tabled before, failed to provide context, funding or a vision to revitalise and reactivate Bridge Road - My question is a good example of this lack of vision.

Bridge Rd has the highest vacancy rate in Melbourne and currently reported that 40 sites have been taken off the market to become development sites.

Council has stated openly that it has no funding available to improve local amenity, notwithstanding 1000 apartments are being built/ have been built in the immediate vicinity of Richmond Hill and spilling onto the roadway without adequate footpath space.

Over the last two years Bridge Rd Mainstreet have been encouraging discussions between Council and Coles to collaborate on an off street public parking facility, as part of their development to improve amenity and public realm outcomes for the immediate area, especially with the new High School, local administration and a central sporting complex.

The offer is an added basement to provide a 180 space public underground carpark - 2 hr free, number plate recognition, with pedestrian access through its mall to an entrance and thence to Citizens park area, the new High School and the Town hall area.

I believe that Coles has now written letters to CEO of Yarra and Minister stating that they need a decision by Christmas otherwise they will proceed regardless. Coles is also apparently still waiting for Council to confirm when they are going to brief the Councillors.

Have Councillors been briefed and whether a way forward has been activated to shape a future outcome for this valuable community asset?

Friends of Baucau has continued to meet monthly, at venues alternating between Darebin and Yarra, to further the partnership with the community in Baucau and the representative organisation UNAP, and to raise funds for various projects supporting the Baucau community.

Fundraising in 2017

Successful fundraising events were held this year with a Trivia Night in June, a Timorese Cultural Evening in October and a movie fundraiser last week. Friends of Baucau also raise funds through regular sales of coffee at community events and through packaged coffee. Yarra Council has recently arranged to sell packaged coffee at Richmond Town Hall. Council also donates funds from the sale of booklets at Carols by Candlelight to Friends of Baucau.

Funds raised support Afalyca, a community arts centre in Baucau which provides skills for young people and is integral in community development. Funds also support scholarships for young people to schools in Dili, supporting people from remote areas to a town centre to participate in training and conferences in a town centre, materials and equipment for the friendship group in Baucau, the provision and maintenance of solar lighting and a range of other requests such as material support following floods or other natural events.

All travel by Friends of Baucau members to Timor Leste are covered by the individuals.

Memorandum of Understanding between Friends of Baucau and UNAP

Friends of Baucau has an MOU with the corresponding organisation in Baucau, UNAP. This was to be renewed during a visit of FOB members in July this year as part of the election observer contingent. However it was apparent that more time is needed to clarify the terms of this MOU and it's hoped it will be renewed in 2018.

Yarra's Municipal Agreement with Baucau

As part of the Municipal Agreement signed in 2014, Yarra Council hosted a further delegation of government employees in August for professional development in waste management. Delegates were also guests at the monthly METAC dinner at Belgium Ave Richmond to share their experiences with both the local and Timorese community in Melbourne.

Local Government Victoria continues to convene the Local Government Timor-Leste Network, comprising local governments with Municipal Agreements, and other network representatives. The network met last week and with an update from LGV on the Victorian Government's forthcoming Timor-Leste Strategy, gender inclusion scholarships, further training for programmes and services in preparation for local government and further professional development exchange visits.

The Urban Planning and Waste Management Training Programme (which Yarra has been part of) will continue, with the TL government requesting more technical placements.

The current lack of resolution following the national elections in July is making planning for many joint activities difficult but it's hoped this will be resolved soon. The uncertainty is also delaying the transition to local government but Baucau is expected to be one of the first municipalities to be established and Yarra's support role will be important at that time.

10. Questions without notice

10.1 Councillor Bosler - Interim Heritage Controls for Collingwood

Question:

When will South Collingwood have its Strategic work completed and ready for applying to the Minister for interim controls and with regard to the recent Ministers advice, has sufficient work been done to allow a request for immediate interim heritage controls for South Collingwood?

Response:

The Director Planning and Place Making advised this is related to Wellington Street, that study and the other major one around Bridge Road and Victoria Street are proceeding well and Councillors have been informed. We hope that this will be finished around February or March next year, and with that solid information, we may well be in a position to seek interim positions. We will not be able to bring that to Council until the study is complete.

10.2 Councillor Stone - Government Road Projects

Question:

A recent announcement by the State Government is that they will proceed with two major road projects, both of which Council have made submissions against because we know you can't build your way out of congestion and the impacts it will have on traffic in the inner city. One of those was the North East link route A, with a combination of a bus route transit down the median. I understand that part of that plan is to have those buses doc at Victoria Park Station or in that vicinity. Have there been any discussions between the relevant department and Council officers about that proposal and the impacts on Yarra?

Response:

The Director Planning and Place Making advised that in relation to the North East link and bus aspect, to my knowledge there has not been any discussions with that agency. I have advised the Strategic Planning staff to provide some brief notes so Executives can get their mind around that topic and then we can talk to Councillors. I have read the media reports around Victoria Park as well, how that would work in terms of getting buses in and out of that is a mystery at the moment and not clear on what the agency proposes.
