  - (c) requests that the report in (d) be provided in the fourth quarter of 2019 in order to progress the redevelopment of the Chas Farquar complex in the 2019-2020 financial year.

That Council, acting under section 17 (4) of the *Road Management Act* 2004, resolves that the road between 5 and 7 Brunswick Street, Fitzroy which is shown as lot 1 on the plan contained in Attachment 1 to this report, being part of the general law land contained in book Syd no. 801 (Road), be removed from Council's Register of Public Roads on the basis that the Road is no longer reasonably required for general public use.
- 2. That Council, acting under clause 3 of schedule 10 of the *Local Government Act* 1989 (Act):
  - (a) Resolves that the required statutory procedures be commenced to discontinue the Road, shown as lot 1 on the title plan attached as Attachment 1 to this report;
  - (b) Directs that, under sections 207A and 223 of the Act, public notice of the proposed discontinuance be given in the appropriate newspapers, social media, any adjoining properties and attached to the site;
  - (c) Resolves that the public notice required to be given under section 207A and 223 of the Act should state that if the Road is discontinued, Council proposes to sell the Road to the Applicant for market value (plus GST); and
