7. Public question time

7.1 Margaret O'Brien - Gift Policy

Question:

Having in mind, the current inquiry into Casey Council by the Independent Broad Based Anti-Corruption Commission, (IBAC), will Council publicly release its procedures for gifts and hospitality for councillors and staff, and place the registers of these items on public display?

Response:

The Mayor advised that Council has both a Staff Code of Conduct and Councillor Code of Conduct and both are already listed on the Council website. I have also spoken with our Governance Officer and Compliance Officer and there are two subdocuments which are administrative documents that are not currently on the website, but that is something that we can consider putting on the website if that is something the community wants. There is also a review of the process going on at the moment and Mr Thomas who is our Senior Governance Advisor has advised that he would be happy to get in touch with you and talk you through the review process.

7.2 Jen Rutherford, Collingwood Toy Library - Community Space

Question:

In the last four years we have grown significantly and doubled our membership from 300 to over 630 local families and as a result we are rapidly running out of space to maintain our current operations and in the near future this will start to limit the work we are already doing to help Council respond to recognised family services and early years community needs.

What can Council do to help us find a bigger space where families have more room to connect with the next few years? The rationale behind this; social connectedness has a positive impact on the mental health and emotional wellbeing of families in particular parents who can often feel isolated. In a bigger space we will be able to support more parents and their children and provide more opportunities for them to meet others, connect and get involved in the community.

Response:

The Mayor advised that community space as you can imagine is highly sought after and in high demand in Yarra and I think I get request on a monthly if not more frequent basis for use of community space and the particularly tricky area is the exclusive space you are after, it's not like our other community groups that usually need space one day a week and with the exclusive use you can't really share that space. I recognise the challenges and I think the best combination is something that you have at the moment where you have a shared space with a business like Collingwood Football Club that provides the facilities that you need. I am happy to take up the cause and assist in advocating to the state government.

Cr Jolly – In relation to the Collingwood Town Hall precinct, we have the situation with the Soldiers and Sailors site that the RSL have pulled out. Not just that site but the whole area. Can you provide Council with the latest update on where we are at with that because I think that the Collingwood Toy Library needs to be part of that conversation as on the rare occasion part of that is Council owned?

The Director Community Wellbeing advised that Felicity Macchion, Manager Yarra Libraries and I meet with the Collingwood Toy Library last Thursday so we are very aware of the issues and concerns they have in terms of space for the extremely valuable service they provide. We do recognise that there are some possible future developments, we don't have a formal direction by Council on that specific management just yet and certainly we will be bringing further reports to Council in the coming months to seek that, but certainly do recognise that that is potentially an opportunity and just for Council's further information. Collingwood Toy Library currently utilises around 150 metres and understand would be looking at around 300 metre mark, effectively double the size and would require a range of other things such as a kitchen, better storage and a range of other things. Space in Yarra is extremely contestant, we have direction from Council to include community services in any future Collinwood Town Hall development, but we also recognise this may be contestant around a general book library, art space and a range of other things that will need to be considered. We will be bringing those opportunities back to Council for consideration and determination. Officers have undertaken to meet regularly with the Collingwood Toy Library to explore opportunities moving forward.

Cr Stone – When will a further report come to Council because I think we have talked about other Council services that might be relocated, there is really nice synergies with the toy library and the maternal child health for example, if they could work together?

The Director Community Wellbeing also advised that it is hard to provide a definitive answer on that as there has been a range of things that I am not able to discuss all in a public forum but certainly we are also negotiating with the department of health and human services around a feasibility study. The department have also gone through a senior staff turnover that has affected it and also some internal capacities that we are working through. We had originally intended to start the feasibility study early next year and we still planning to do that and have also written to the department in order to get some direction from them and have been given the undertaking that they will provide some funding, and are waiting on a response.

Cr Fristacky – asked the submitter – When is the termination of the lease and what time frame are you seeking?

Ms Rutherford advised that it was currently on a rolling lease that is due for renewal in about 3 years and given it would take a long time to find a new space, the sooner the better.

DELEGATES REPORT

NAGA comprising the 9 local government areas of Darebin, Banyule, Hume, Manningham, Melbourne Moreland, Nillumbik, Whittlesea and Yarra recently held a breakfast briefing by Sarah Barker from Minter Ellison. The focus of the briefing will be corporate climate change risk for local governments.

The impacts of climate change upon council assets and the community are increasingly at the heart of corporate risk concerns of Australian local governments. Sarah discussed corporate governance, financial and liability implications of climate change risk and how this can be communicated across your council.

Sarah has two decades' experience as a corporate lawyer and is regarded as one of the world's foremost experts on investment governance issues relating to climate change, ESG (environmental, social, governance), and the UN Sustainable Development Goals. Her leadership in climate risk adaptation and resilience is internationally recognised and has been called upon by institutions from the Bank of England to the OECD, European Union and United Nations Principles for Responsible Investment. She has many other credentials and has addressed councillors and local government officers in a range of settings during this year.

Her main message was that finance and insurance markets have already shifted to factor in climate change and it needs to be factored into everything we do. That includes in local government,

She highlighted the physical exposure to climate change faced by local governments, especially through secondary costs of natural disasters in other states; and the economic transition risks as markets respond to climate change. She described the Paris Agreement (signed up to by all but 2 nations) as "the mother of all market signals", in the move towards a decarbonised global economy by 2050. Markets will follow - with the examples of internal combustion engines being banned in numerous countries, and price parity in the UK by 2020. With the risk to assets, including councils', in a 4 degree world, it's in everyone's interests to "get on the transition train".

With most NAGA councils having declared a climate emergency, her message resonated with those present. However, it also highlighted the significant changes in approach to risk management that all councils need to undergo, in the uncharted territory of a climate changed world where some past practices will no longer apply and an "act of God" or force majeure in contracts is no longer recognised.

Yarra's Climate Emergency Plan will provide an opportunity for Yarra Council to address the risks she highlighted and protect our community and assets in future

scenarios of increased temperatures and extreme weather events.

DELEGATES REPORT

Project Respect was established in 1998 as a service supporting women in the sex industry, women who have been trafficked and to advocate for change needed to end all forms of sexual exploitation. It employs a modest number of staff and works on a peer worker and outreach model which has had great success.

Project Respect is also housed in one of Council's properties and has received financial and in-kind support from Yarra Council over many of the past 20 years.

This year, Project Respect has celebrated its 20th birthday, beginning with a forum at Fitzroy Town Hall on human trafficking globally, and the new Australian legislation on trafficking, and concluding with an event at Parliament House in September, shared by former MP Neil Cole and Rosie Batty and the women who have both supported and been supported by the organisation over the past 20 years.

Programs have expanded in recent years from outreach and case management, to pathways to employment, training of other organisations who work with women in the sex industry or who may encounter women who have been trafficked, secondary consultations and referrals to other organisations. Of the women supported, 38% are Australian born, 23% Chinese, 10% Thai, 17% Korean and the remainder from a range of nations. The highest demand during outreach is for education and training.

A positive story for Project Respect in the past year has been the broadening of support from local government. From support from Yarra and just 2 other councils 10 years ago, Project Respect has received support from 9 councils in metropolitan Melbourne in the past 12 months, as well as state government and philanthropic organisations. Financial support is not guaranteed however and fundraising is an ongoing focus of the organisation.

10.1 Cr Stone - Car Share

Question:

Question from resident Keith Fitzgerald who has asked how council can help facilitate increased car share and car-pooling along the Eastern Freeway to reduce demand and future pressure on freeway expansion.

What opportunities are there to influence car share or car-pooling and will this be considered in the Integrated Transport Strategy?

Response:

The Director Planning and Place Making advised that Council are certainly seeking to promote car share within the municipality and you have received an adopted policy and coming back to you with an implementation plan on that but the question that has been put really relates to car share towards Yarra or away from Yarra and into Yarra. There would be advocacy as part of that and that could be, also aspects of a potential fee structures with North East Link so there would need to be some thinking on that and limited ways that Council could seek to influence probably indirectly rather than direct. Happy to take it on notice and speak with staff and that could be a consideration as part of the thinking of integrated transport strategy.

Cr Jolly also added, if Councillor Searle as the MAV representative to raise this at

the MAV to potentially look at a joint campaign with municipalities in the eastern suburbs on this matter.

10.2 Cr Jolly - Intersection at Hoddle Street and Roseneath Street

Question:

Residents in east Clifton Hill have requested I ask a question in relation to the traffic lights on the intersection on Hoddle Street and Roseneath Street. If you're a pedestrian or even a cyclist it can sometimes take 10 minutes to cross due to the lack of synchronicity between the railway and the traffic lights.

If Council, either through the Mayor's office or relevant Director can lobby with PTV and VicRoads to look at a better syncretisation between the traffic lights and the boom gates so that pedestrians have priority on Hoddle Street and using smart traffic signals?

Response:

The Director Planning and Place making took the question on notice and advised that a letter could be sent as part of the active transport advocacy and promotion.

 - (b) the inclusion in this Bill of Section 13 which removes the provision for multi-member wards;
 - (c) the recommendations by the Victorian Electoral Commission in recent electoral reviews of multi-members wards in most instances;
 - (d) the widespread sector opposition to the removal of multi-member wards;
 - the deep concern expressed by the local government peak bodies, the Municipal Association of Victoria and the Victorian Local Governance Association about the removal of multi-member wards;
 - (f) the lack of support for the removal of multi-member wards throughout the prolonged consultation process during 2015-2018;
 - (g) support expressed in the Yarra community for the continuation of multi-member wards; and
 - (h) the lack of specific sector consultation on this aspect of the Bill.
- 2. That Council re-state its opposition to mandating single member wards for the following reasons:
 - Council wards should be structured to best suit the differing geography, demographics and governance of municipalities and collective decision making in the interests of the community as a whole;
 - (b) single member wards are highly limiting for smaller geographic Councils like Yarra, Port Phillip or Queenscliff;
 - (c) the requirement for all Councillors to be elected from single-member wards has the effect of abolishing proportional representation;
 - (d) proportional representation allows for voters who favour independents and small political parties to have their views represented on Council;
 - (e) each State and Territory Parliament with the exception of Queensland and the Northern Territory has a proportionally elected house, and the Federal Senate is proportionally elected;

- (f) the number of municipalities with Councillors elected from single-member wards has decreased from 43 in 2003 to 7 in 2019, due to Victorian Electoral Commission (VEC) representation reviews consistently recommending multi-member wards and that VEC representation reviews involve extensive community consultation and analysis of the impacts of each model;
- (g) the 2016 State Government Commission of Inquiry into the City of Greater Geelong highlighted single-member wards as a contributing factor in the dysfunction and poor governance of that municipality, and since that inquiry, the City of Greater Geelong has had multi-member wards;
- (h) single-member wards were not canvassed in the government's 2016 discussion paper or the 2013 Petro Georgiou discussion paper;
- (i) a single Councillor in each ward would mean that in the event of a Councillor being unable or unwilling to fulfil their duties, the local community would have no other ward Councillor representation;
- (j) single-member wards have resulted in uncontested elections in other municipalities;
- (k) Councillors are required to represent the entire municipality and having wards with a very small geographic area is in conflict with this principle;
- the proposal will require by-elections for each ward vacancy, resulting in lack of representation of constituents during the vacancy period, and require more costs and delays in filling vacancies, in lieu of the proposed improved count-back system for filling vacancies;
- (m) current wards would need to be separated into multiple wards, potentially separating communities of interest from each other; and
- (n) 41.69% of Victorian Councillors elected from multi-member wards are women, vs. only 33.9% in single-member wards.
- 3. That the Mayor write to the Minister for Local Government The Hon Adem Somyurek MP asking him to pause the progress of this Bill and engage fully and respectfully with the local government sector on this issue.
