#### 4.1 Draft 2020/21 Budget - Hearing of Submissions

Trim Record Number: D20/120230

Responsible Officer: Director Corporate, Business and Finance

#### **Purpose**

1. To hear any person who wishes to speak in support of a written submission to the draft 2020/21 Budget in accordance with section 223 of the Local Government Act 1989 (the Act).

#### **Background**

- 2. Council is required to adopt a Budget under Section 130 of the Act and must give public notice of its decision.
- 3. Under Section 223 of the Act, Council is required to:
  - give public notice outlining how the community can access a copy of the budget, timelines for submissions (at least 28 days) and the option to speak to their submission at a Council meeting;
  - (b) receive submissions;
  - (c) hear submissions at a Council meeting (where submitters have requested that opportunity); and
  - (d) write to each submitter noting Council's decision and the reasons for it.
- 4. The process of community engagement to inform development of the draft 2020/21 Budget commenced in late 2019. The initial round of community consultation assisted Council to understand a range of community sentiments and priorities for the budget.
- 5. Following this informal consultation process, Council formulated a draft Budget to fund services Council provides and additional works, services, and programs Council determined were priorities for the coming year. This was subsequently revised with the significant impact of Covid-19 and Council's financial support package response.
- 6. A draft 2020/21 Budget was presented to the Ordinary Council meeting on 19 May 2020 and was adopted in principle, for the formal advertising and consultation process.
- 7. The restrictions introduced by Federal and State Governments in response to Covid-19 prohibited face to face engagements with our community. In response Council undertook extensive on-line and social media campaign to engage the community.

#### **External Consultation**

- 8. The draft 2020/21 Budget was publicised via:
  - (a) a formal public notice in The Age and Council's website on Friday 22 May 2020;
  - (b) Yarra News feature (to 55,000 addresses);
  - (c) Yarra Life (to 10,000 subscribers);
  - (d) Facebook promoted post and video (to 9,000 followers and beyond);
  - (e) Twitter video (to 5,000 followers);
  - (f) Your Say Yarra direct message (to 1,000 subscribers);
  - (g) Your Say Yarra Mayoral Video:
  - (h) Budget hotline for enquiries and questions:
  - (i) Message to Advisory Committee representatives;
  - (j) Direct email message to Neighbourhood Houses, community organisations, service providers and interest groups:

- (k) Promotional posters at Public Housing Estates, and:
- (I) Yarra website news item.
- 9. The draft 2020/21 Budget was available for public inspection for 30 days with the community having a number of options for submitting feedback including formal submissions received via email, online on Council's website and post as stipulated under s223 of the Local Government Act.
- 10. People making formal submissions to the draft 2020/21 Budget could elect to be heard on their submission at this Special Council meeting. This process has been adapted to proceed under the current social gathering restrictions.
- 11. At the close of formal submissions on Friday 19 June 2020, Council had received 66 submissions. Some submitters raised multiple issues in their submission with 103 comments being received across 52 issues, aligned to the Council Plan's Strategic Objectives.
- 12. Of the 66 submitters, 52 were from Yarra residents.
- 13. A summary of the issues raised in the submissions can be found at **Attachment 1**.

#### **Internal Consultation (One Yarra)**

14. The Governance branch has provided advice to ensure compliance with the legislative obligations of the Local Government Act 1989.

#### **Financial Implications**

15. The Budget process is guided by legislation and has major financial implications for Council's current and future operations and financial direction into the future.

22. The requirements of the Local Government Act 1989 have been applied to the proposed budget preparation process, including: giving public notice of the submission period; receiving public submissions; and hearing those submissions who specifically requested to present verbally.

23. There are no other issues to be considered in this report.

#### Conclusion

25. Council has received submissions and feedback on the proposed 2020/21 Budget. The Submissions Hearing provides an opportunity for submitters who requested to be heard in relation to their submission to be invited to do so.

  - (a) hear oral submissions on the Draft 2020/21 Budget in accordance with section 223 of the Local Government Act 1989; and
  - (b) note that the written submissions received through the statutory consultation phase and submissions heard tonight will be considered by Council on 4 August 2020.
