Mayor:

Each year, we honour the everyday heroes who make outstanding contributions to the community with our Yarra Community Awards.

This year's Community Awards are particularly significant as we will be recognising those individuals and groups who have supported our community during the COVID-19 pandemic. These contributions will be recognised in a special award category titled Community Spirit.

The challenges and community contributions during the past two years have been significant. The way we have responded to these challenges and at times opportunities demonstrates how connected and supportive the people of Yarra are.

On behalf of myself and my fellow councillors, we are incredibly grateful and proud of the work our community has done in supporting each other during this time. We know the recovery work and rebuilding will continue over the coming years – as we reopen and reconnect.

I'd also like to acknowledge and thank everyone who submitted a nomination for this year's awards. It's always uplifting and inspiring to learn more about the fantastic projects and people within our community and we can't wait to share their stories with you. I think we all deserve some good news!

This year, we have eight awards to present:

- Four awards in our 'Contributions to' categories, including Contributions to Arts, Contributions to Diversity and Inclusion, Contributions to Heritage and Contributions to Sport.
- Our Community Spirit Award this year's special category
- Our Community Initiative of the Year
- Young Citizen of the Year
- And our Citizen of the Year.

We thank all of our incredible nominees who are tuning in tonight. While we will be unable to hear from our winners this evening, we will gather with the winners and councillors for a morning tea celebration in the coming weeks.

I will now invite Cr Edward Crossland announce the winner of our Contributions to Arts Award.

Cr Crossland:

Thank you, Mayor. I am delighted to announce the winner of this year's **Contribution** to **Arts Award** is **Caroline Philips**.

Caroline is an inspirational leader and advocate for women's art through her volunteer work with the Women's Art Register. The Women's Art Register is a living archive of women's art practice and an artist-run, not- for-profit community and resource.

Caroline recently led an initiative to digitise the register's largely paper- based archives. Caroline also facilitated the register's online transition during lockdowns, ensuring its important work could continue – while also balancing volunteers' capacities and wellbeing.

Thank you, Caroline, for your ongoing contributions to art in Yarra.

I'd also like to acknowledge the broader arts community in Yarra. The past two years have been exceptionally challenging – and it has been heartening to hear of the creative and innovative ways this community has adapted during the lockdowns.

A special shout-out to the Disorganising Project – who have created connections between community members, artists and thinkers to experiment with divergent ways of organising and creating.

Cr O'Brien:

Thank you, Mayor. The winner of our **Contributions to Diversity and Inclusion Award** for 2021 is **Ha Nguyen**.

Ha receives this award for his volunteer work on the Victoria Street Lunar New Year Festival and the North Richmond Moon Lantern Festival. These festivals are a wonderful celebration of our vibrant and diverse cultures in Yarra – and delight community members of all backgrounds.

Ha has a long history of volunteering for these festivals and has become the driving force behind them.

In addition to his volunteer work on the festivals, Ha is also the president of the Victoria Street Business Association and is a member of the Rotary Club of Collingwood – where he donates both time and the use of his cooking school for community initiatives.

Thank you, Ha – for your ongoing contributions to diversity and inclusion in Yarra.

A special mention goes to **Selima Ymer**, for her volunteer work with the Albanian Australian Islamic Society (AAIS) for more than 20 years of service. Thank you Selima.

Cr Crossland:

Thank you, Mayor. This year's winner of our **Contributions to Heritage Award** is **Terence Nott.**

Terence receives this award for his significant contribution to the protection of heritage in Yarra and beyond.

Terence is passionate about preserving and looking at adaptive reuse of buildings with historical significance – and has been volunteering in this space for the past five decades.

More recently, Terence has been an active member of the Queens Parade Heritage Planning and Traders group, using his expertise as a Heritage Architect to provide guidance, research and support on the protection of heritage in this area.

Thank you, Terence, for your ongoing contributions to heritage in Yarra.

A special mention goes to **Glen McCallum** and **Anne Coveny** for their contributions to the protection of heritage and neighbourhood character in Yarra.

Cr O'Brien:

Thank you, Mayor. This year, the winner of our **Contributions to Sport Award** is **Stella Lesic.**

Stella receives this award for their inspiring volunteer work as the President and Founder of Queer Sporting Alliance. Stella has grown the alliance from one local basketball team to Australia's largest LGBTIQA+ multi-discipline community sports club – with over 500 members.

Stella has contributed hundreds of volunteer hours to improving diversity and inclusion in community sports in Yarra. Some of the highlights of their volunteer work include the Sunday morning "Come Out and Play" free basketball sessions and the "Come Out and Roll" free roller-skating sessions.

Thank you, Stella, for your ongoing contributions to sport in Yarra.

A special mention goes to Annette Hall for her ongoing volunteer work with an inclusive football program that caters for players with additional needs.

Cr Crossland:

Thank you, Mayor. This year, I am pleased to announce the winner of our Community Initiative of the Year Award is Michelle Edwards and the Community Compost Group.

The Community Compost Group provides a place for the local community to bring their vegetable food scraps, rather than sending food waste to landfill.

Michelle leads a small group of volunteers to manage this popular community compost bin system, helping to turn food waste into useable compost.

A considerable amount of volunteer work goes into managing the program and coordinating the highly physical work involved in maintaining the compost system.

Thank you, Michelle and the Community Compost Group for your ongoing contributions to the Yarra community.

A special mention goes to Tina Brunet for the "This is Me" event – celebrating women being their authentic selves and championing diversity and inclusion.

Cr O'Brien:

Thank you, Mayor. This year, I am pleased to announce the winner of our **Community Spirit Award**. As the Mayor mentioned earlier, this is a special category added this year to recognise the individuals and groups who have supported community recovery and resilience during the COVID-19 pandemic.

The winner of our Community Spirit Award is Lyndsey Watson.

Lyndsey has a long history of volunteering in our local community as a program coordinator with the University of the Third Age.

During the lockdowns, Lyndsey organised with Yarra Libraries to extend the university's programs to the broader Yarra community, not just its members.

Lyndsey rose to the challenges presented by Melbourne's six lockdowns by not only upskilling herself in Zoom but also upskilling the university's members and tutors in delivering talks using Zoom and PowerPoint. This enabled the university to successfully transition to delivering its programs via Zoom during lockdowns.

Lyndsey was also instrumental in the university's initiative to check in on the wellbeing of isolated or 'at risk' members during lockdown.

Lyndsey - thank you for your dedicated work in fostering community spirit and resilience during the past year, and for your ongoing contributions to our community.

I would also like to thank all those individuals and groups who were nominated for this special award. We were in awe of the number and quality of responses received for this category.

There were many inspirational examples of people going above and beyond to deliver their programs and initiatives during lockdowns. From online scout programs and wool craft workshops to homework clubs for vulnerable students – we couldn't be prouder of how our community supported each other during this time.
