6. Question Time

This record is provided from members of the public upon registration and also asked during Question Time and the responses provided is not a transcript of proceedings. A recording of the Council Meeting is available on Council's website.

The following questions were asked:

1. Herschel Landes:

Question:

What evidence is there that the Mayor had those conversations and has the Mayor engaged in misleading this council and the community in a decision making process?

The Mayor provided the following response:

Every single day as the Mayor of this Council I meet with people at the state level, sometimes at the federal level and definitely my colleagues of the council. Last fortnight, as an example, when in Canberra, we met with Mayors and Councillors from all over Australia. The Lord Mayor of the City of Melbourne and I are very close friends and just because I didn't provide you, through an FOI, with a text message or an email doesn't mean that exhausts all possibilities of how I discuss with the Lord Mayor of City of Melbourne. I've discussed with the Lord Mayor of the City of Melbourne about the Elizabeth Street bike lane, I've discussed with elements of the state government on the same issue, and if you don't believe me, I would make one suggestion, call the Lord Mayor, I can give you his number, you're an ex-councillor, so I trust you, I know you just wont put it on social media, ring him up and ask him, have you ever discussed this matter, I can tell you where we met, I can tell you about the conversation, because we are very, very proud of the decision we have made in relation to Elizabeth Street and it will be co-defied in next months council meeting. We are bringing Elizabeth Street back to the people of North Richmond, to the Vietnamese community, to the businesses, to the temple, something that the last council didn't do and we are very, very proud. We are not taking a backward step on this, and if you want to check with the City of Melbourne, go and check, I can give you the number, so thank you for your question.

2. Shane Delphine:

Question:

The state government recently announced the trial of a pill testing centre at 95 Brunswick Street, Fitzroy.

Residents surrounding the site may be concerned that the area will become a drugdealing precinct as police activities will have to be minimal to allow for effective operation of the centre.

Furthermore, all Yarra ratepayers may be concerned about additional costs that may be borne by Council as a consequence of the trial.

Can Officers please provide details of any consultations that the state government has had with Council to provide assurance that Yarra residents are not unduly burdened by the trial?

The General Manager Community Strengthening provided the following response:

Thanks for your question.

Council was advised of the establishment of the fixed site pill testing service by the Department of Health on the same day as it was publicly announced by the State government.

Shortly after receiving this advice, our CEO and senior staff met with senior representatives from the Department of Health.

Council officers are participating in an Implementation Working Group, led by the Department of Health.

We have and will continue to raise specific risks including proximity to Connie Benn Early Years centre, Fitzroy Youth Hub, public housing, and existing public congregation locations.

Further, our request to have the Working Group's Terms of Reference amended has been accepted, which now include critical issues such as identifying and addressing precinct-level public safety and amenity impacts.

3. Elizabeth Clarke:

Question:

Yarra's Developer fund has \$30million, The Charlotte Street library park was designed, budgeted for and passed by the last council to benefit all users of Richmond library. It was scrapped by the new council, under pressure from comfortable Elm Grove residents. The Mayor said new Cremorne parks were under negotiation, which they have been for who knows how long. Then Cr Davies said work on the new library would wreck any new park. A reimagined library would take funding, planning and years. Given trees take ages to grow, why not work on Library park while negotiations continue for the Cremorne park?

The Acting General Manager Infrastructure and Environment provided the following response:

Thank you for your question, Elizabeth.

At the 26 November 2024 council meeting, council determined not to proceed with the delivery of the Charlotte Street.

In relation to new open space, officers continue to explore land acquisition opportunities in Cremorne to expand public open space and are actively progressing options in the area.

Once the process reaches a more advanced stage, proper and inclusive community engagement will be undertaken.

4. Joe Gagliano:

Question:

Despite committing to 'review' parking sensors, no time limit was given to this commitment. Unfortunately, this football season has seen increases in parking illegally near MCG precinct. Parking officers are doing their best, and can easily book on no parking without permit areas. With many sensors are not working in the 1P allowed, parking officers do not have time to mark tyres and return an hour later- when sensors are not working. Yarra is missing out on thousands of dollars.

I request a time frame, and time limit - preferably before the finals season - to the sensor review works.

The General Manager City Sustainability and Strategy provided the following response:

Thank you for the question Joe. I am aware that you have had many discussions with Council officers regarding parking in the MCG precinct, including an on-site meeting earlier this year.

I understand at that meeting, Council officers undertook to continue proactive patrols in the area and to review the parking sensors. Since then, Council's contractor has been reviewing and replacing sensors and to date 195 have been replaced in the area. The Contractors are continuing to work on this and anticipate that all priority streets will be completed before the finals season.

5. Jane Keech:

Question:

Can the cypress hedge at 93 Fenwick Street, Carlton North corner Sutton Street be cut back to maximal amount and be saved? It overhangs the street and is currently subject to a Council compliance order (to be cutback to the fence line, which would destroy its integrity) and require it to be removed.

The CEO provided the following response:

The hedge and the home sound beautiful. I can't answer the question right now as I don't know the specifics but I'm sure that we will be able to find a way to work with you to balance both, even if we take a progressive approach. The reason why the teams require overhanging greenery into the footpath space to be managed, is because it creates a hazard for people using the footpath, so we have to balance those objectives. I will direct the General Manager, Mary Osman to reach out to you to talk through the details and get someone down to talk it through with you.
